### Ordinance 2004-01 through 2001-04

- 2004-01            AN ORDINANCE REQUIRING MOVE-ON PERMIT BEFORE ANY MOBILE/MANUFACTURED HOME SHALL BE MOVED ONTO ANY RESIDENTIAL LOT WITHIN THE TOWN OF LEE; REQUIRING RECERTIFICATION OF ANY USED MOBILE/MANUFACTURED HOME; SPECIFYING MINIMUM REQUIREMENTS FOR RECERTIFICATION; AND PENALTIES FOR VIOLATION OF THE ORDINANCE AND PROVIDING AN EFFECTIVE DATE.
- 2003-06            AN ORDINANCE OF THE TOWN OF LEE OF MADISON COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR THE FISCAL YEAR 2003/04; PROVIDING FOR AN EFFECTIVE DATE: ADOPTION OF BUDGET 10/01/03-9/30/04
- 2003-05            AN ORDINANCE OF THE TOWN OF LEE, FLORIDA LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2003, AND ENDING SEPTEMBER 30, 2004, STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS LESS THAN THE ROLLED-BACK RATE; AND PROVIDING AN EFFECTIVE DATE: 10/01/03-9/30/04
- 2003-04            AN ORDINANCE OF THE TOWN OF LEE, FLORIDA, WHICH DEFINES "AUXILIARY EXHAUST BRAKES" AND WHICH PROHIBITS THE USE OF AUXILIARY EXHAUST BRAKES IN THE CITY LIMITS OF THE TOWN OF LEE EXCEPT IN THE CASE OF AN EMERGENCY, WHICH PROVIDES FOR SIGNS TO BE PLACED WITHIN THE CITY LIMITS, WHICH PROVIDES FOR CIVIL PENALTY, PROVIDES FOR SEVERABILITY AND PROVIDES FOR AN EFFECTIVE DATE.
- 2003-03            AN ORDINANCE OF THE TOWN OF LEE ADOPTING ORDINANCE 03-127 OF MADISON COUNTY, FLORIDA, AMENDING AND RESTATING ITS ORDINANCES NOS. 97-89, 98-91, AND 99-104; REESTABLISHING A COUNTY-WIDE STREET NAMING AND ADDRESSING POLICY AND PROCEDURES TO ASSIST EMERGENCY SERVICES AGENCIES, THE UNITED STATES POSTAL SERVICE AND THE PUBLIC IN THE TIMELY AND EFFICIENT PROVISION OF SERVICES TO RESIDENTS AND BUSINESSES OF MADISON COUNTY; NAMING ALL STREETS; POSTING STREET SIGNS; ASSIGNING ADDRESSES TO ALL ADDRESSABLE STRUCTURES; REQUIRING THE POSTING OF ADDRESSES; PROHIBITING CERTAIN ACTS; PROVIDING FOR ENFORCEMENT AND PENALTIES FOR THE VIOLATION OF THIS ORDINANCE; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.
- 2003-02            AN ORDINANCE RELATING TO REZONING LESS THAN FIVE PERCENT (5%) OF THE TOTAL LAND ACRES OF THE TOWN OF LEE: PROVIDING FOR REZONING OF CERTAIN LANDS WITHIN THE TOWN OF LEE; REPEALING ORDINANCES IN CONFLICT: REZONING TOM PRATOR-LEE TRAILER & SCHOOL AVE. PARKS
- 2003-01            AN ORDINANCE PROMULGATING THE RATES TO BE CHARGED FOR USE OF THE MUNICIPAL RATES WATERWORKS SYSTEM: OUTLINING MEANS OF ENFORCING PAYMENT FOR WATER SERVICE, PROMULGATING REQUIREMENTS FOR CONNECTION TO THE MUNICIPAL WATER WORKS SYSTEM, SETTING UP MAINTENANCE REQUIREMENTS: PROHIBITING FREE WATER SERVICE AND PENALTIES FOR VIOLATION.

- 2002-04 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2002, AND ENDING SEPTEMBER 30, 2003, STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS LESS THAN THE ROLLED-BACK RATE; AND PROVIDING AN EFFECTIVE DATE: 10/01/02-9/30/03
- 2002-03 AN ORDINANCE OF TOWN OF LEE, FLORIDA; PROVIDING FOR FINDINGS OF FACT, INTENT AND DEFINITIONS; REGULATING THE COMMERCIAL NOT PASSED MERCHANDISING OF TOBACCO PRODUCTS; PROHIBITING PLACEMENT OF TOBACCO PRODUCTS IN OPEN DISPLAY UNITS DIRECTLY ACCESSIBLE TO THE PUBLIC; PROVIDING FOR EXCEPTIONS; PROVIDING FOR ENFORCEMENT; AND PROVIDING FOR AN EFFECTIVE DATE: REGULATING TOBACCO.

- 2001-05 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2002, AND ENDING SEPTEMBER 30, 2003, STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS LESS THAN THE ROLLED-BACK RATE; AND PROVIDING AN EFFECTIVE DATE:  
10/01/01-9/30/02
- 2001-04 AN ORDINANCE OF THE TOWN OF LEE CONSENTING TO HAVE ALL OF THE MUNICIPAL BOUNDARIES OF THE TOWN OF LEE INCLUDED WITHIN THE BOUNDARIES OF ANY MUNICIPAL SERVICES BENEFITS UNITS ENACTED FOR THE PROVISION OF GARBAGE AND TRASH COLLECTION AND DISPOSAL SERVICES AND FIRE PROTECTION SERVICES; PROVIDING SUCH CONSENT FOR A TERM OF YEARS; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.
