- 2006-04 AN ORDINANCE OF THE TOWN OF LEE TO ANNEX CERTAIN PROPERTY CONTIGUOUS TO THE TOWN OF LEE AND REDEFINE THE BOUNDARY LINES OF THE TOWN OF LEE TO INCLUDE SAID PROPERTY; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING AN EFFECTIVE DATE. - 2006-05 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2006, AND ENDING SEPTEMBER 30, 2007, STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS MORE THAN THE ROLLED-BACK RATE; AND PROVIDING AN EFFECTIVE DATE.
