- 2001-03 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA, AMENDING 92-1, AS AMENDED, RELATING TO THE REZONING OF TEN OR MORE CONTIGUOUS ACRES OF LAND, PURSUANT TO AN APPLICATION BY THE TOWN COUNCIL OF THE TOWN OF LEE, FLORIDA; AMENDING THE OFFICIAL ZONING ATLAS OF THE TOWN OF LEE LAND DEVELOPMENT REGULATIONS; PROVIDING FOR REZONING FROM AGRICULTURAL (A) TO RESIDENTIAL, SINGLE FAMILY – 1 (RSF-1) CERTAIN LANDS WITHIN THE CORPORATE LIMITS OF THE TOWN OF LEE, FLORIDA; PROVIDING SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE: REZONING PINE TRACE SUBDIVISION
- 2001-02 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA, AMENDING 91-3, AS AMENDED, RELATING TO THE AMENDMENT MORE THAN TEN ACRES OF LAND TO THE FUTURE LAND USE PLAN MAP OF THE TOWN OF LEE COMPREHENSIVE PLAN, UNDER THE REGULAR AMENDMENT PROCEDURES ESTABLISHED IN SECTIONS 163.3161 THROUGH 163.3215, FLORIDA STATUTES; CHANGING THE LAND USE CLASSIFICATION FROM AGRICULTURE (LESS THAN OR EQUAL TO 1 DWELLING UNIT PER 5 ACRES) TO PUBLIC FOR CERTAIN LANDS WITHIN THE CORPORATE LIMITS OF THE TOWN OF LEE, FLORIDA; PROVIDING SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE: NEW LEE ELEMENTARY
- 2001-01 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA, AMENDING 91-3, AS AMENDED, RELATING TO AN AMENDMENT TO THE TEXT OF THE TOWN OF LEE COMPREHENSIVE PLAN, UNDER THE REGULAR AMENDMENT PROCEDURES ESTABLISHED IN SECTIONS 163.3161 THROUGH 163.3215, FLORIDA STATUTES, AMENDING OBJECTIVE IV.4, POLICY IV.5.5, OBJECTIVE V.2 AND POLICY V.2.12 CONCERNING PROTECTION OF HIGH GROUNDWATER AQUIFER RECHARGE AREAS; PROVIDING SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING AN EFFECTIVE DATE.
- 2001-01 AN ORDINANCE OF THE TOWN OF LEE REQUIRING BACKFLOW PREVENTERS FOR ALL RESIDENCE AND BUSINESSES, SETTING MINIMUM STANDARDS FOR CONNECTION, PROVIDING FOR INSPECTION OF BACKFLOWS, PROVIDING FOR VIOLATION; PROVIDING FOR AN EFFECTIVE DATE.
- 2000-1 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA AMENDING CHAPTER 6067 AS AMENDED BY ORDINANCE 78-1, EFFECTIVE MARCH 7, 1978, BEING THE CHARTER OF THE TOWN OF LEE, MADISON COUNTY, FLORIDA, ENTITLED "AN ACT TO PROVIDE FOR A MUNICIPAL GOVERNMENT FOR THE TOWN OF LEE, IN MADISON COUNTY, FLORIDA" AMENDING SECTIONS 2,3,11, AND 22 DELETING INAPPLICABLE PROVISIONS AS CHANGED BY LAWS.

- 99-20 AN ORDINANCE OF THE TOWN OF LEE OF MADISON COUNTY, FLORIDA, ADOPTING THE FINAL BUDGET FOR THE FISCAL YEAR 1999/00; PROVIDING FOR AN EFFECTIVE DATE: 10/01/99-9/30/00
- 99-19 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1999, AND ENDING SEPTEMBER 30, 2000, STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS LESS THAN THE ROLLED-BACK RATE; AND PROVIDING AN EFFECTIVE DATE: 10/01/99-9/30/00
- 99-18 AN ORDINANCE OF THE TOWN OF LEE, FLORIDA, PROHIBITING THE SALE, CONSUMPTION, OR SERVING OF ALCOHOLIC BEVERAGES, BY BOTTLE CLUBS OR BUSINESSES WHOSE PRIMARY PURPOSE IS THE SALE, CONSUMPTION OR SERVING OF ALCOHOLIC BEVERAGES AND WHO ARE WITHIN 1000 FEET OF AN ESTABLISHED CHURCH, DAY CARE CENTER, PUBLIC RECREATION AREA, OR PUBLIC SCHOOL; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.
