- 81-2 AN ORDINANCE TO BE ENTITLED A LAW AGAINST THE ACCUMULATION OF TRASH, GARBAGE, UNHEALTHFUL GROWTHS OR DANGEROUS CONDITIONS, PROVIDING FOR THE REMOVAL OF SAID CONDITION BY THE CITY OF LEE OR ITS AUTHORITY, PROVIDING FOR THE ASSESSMENT OF COSTS INCLUDING A LIEN AND PENALTIES FOR VIOLATION THEREOF, AND PROVIDING AN EFFECTIVE DATE.
